*Having* the common aspiration of the parties to contribute to the development of educational alternatives, regulated by the Education Code of the Republic of Moldova and the increasing number of applicants to benefit from these alternatives;

*Considering* that the provision of a favorable study environment are indispensable conditions for the practical application of the general principles of the educational system in the Republic of Moldova and of the principles of Waldorf pedagogy practice;

*Starting* from the good results registered by the pupils and the graduates of the Lyceum, as well as from the need to offer the possibility for a larger number of pupils to study in the only Lyceum with alternative pedagogy practice, Waldorf in Moldova;

*Wanting* to collaborate to achieve the aspirations mentioned in this preamble, the Parties have concluded this tripartite convention, hereinafter referred to as the **Agreement**, as follows:

### I Objectives:

1.1. Theoretical Lyceum Waldorf, as an exponent of Waldorf pedagogy in Moldova, respects the national legislation regarding the aims of primary, secondary, upper secondary education and contributes by applying them, to the cohesion of these two educational systems;

1.2. The main objective of the collaboration between the parties is to promote the common interests, capable of ensuring adequate conditions for continuous training within the TL Waldorf, thus developing the educational tasks in the Republic of Moldova;

1.3. The parties to the agreement attest that the major problem facing the educational institution, except for the social and cultural plan, is expressed in numerical indicators regarding the areas required for study and auxiliary spaces, which register a critical difficulty that can be overcome by extension;
