

- 4.1.4. Supervises and monitors, within the limits of the competences, the volume and quality of the design and construction works;
- 4.1.5. Requests to the persons responsible for the elaboration of the design documentation and the execution of the constructions, the necessary information for the efficient monitoring of all the stages of implementation of the *Project*;
- 4.1.6. Presents, upon request, to the parties to this *Agreement* and to the competent public authorities, opinions, reports, etc. regarding the works carried out;
- 4.1.7. Examines and analyzes the information requested / presented according to point 4.1.5. within the pedagogical councils and internal or joint meetings with the Foundation;
- 4.1.8. Promotes the interests of TL Waldorf dictated by the objectives of this *Agreement*, internally and externally, in order to obtain the financial support necessary for the realization of the *Project*.

4.2. Waldorf-Moldova Foundation:

- 4.2.1. Selects and contracts jointly with TL Waldorf the competent specialists for the elaboration of the design documentation and the economic agents that will build the constructions included in the *Project*;
- 4.2.2. Authorizes and ensures the financing accepted by own means and/or attracted from the account of alternative national or international sources, all stages of elaboration, realization and implementation of the *Project*;
- 4.2.3. Keeps appropriate record of all contracted services and goods and presents regularly and upon request reports and summary reports with regard to it;
- 4.2.4. Supervises and monitors within the limits of the competences the modalities of use according to the legislation in force of the financial resources, but also the volume and quality of the project and construction works;
- 4.2.5. Promotes the interests of TL Waldorf at the internal and external level, in particular:
- by the direct negotiation of financing possibilities;
 - by active participation in various programs in order to obtain financial support;
 - by other means of collecting the funds necessary for the realization of the *Project*.

4.3. Public authority:

- 4.3.1. Requests the parties the documents and acts necessary for approving and obtaining the documentation of designing and construction of the object described in the *Project*;
- 4.3.2. Verifies and analyzes the submitted documents;
- 4.3.3. Rectify or, as the case may be, request the rectification of the submitted documents;
- 4.3.4. Within the limits of its competences offers consultations and explanations for adjusting the project documentation to the legal requirements;
- 4.3.5. Records according to the legal provisions and the proposed objectives the goods and the constructive elements realized within the *Project*;
- 4.3.6. Ensures proper current maintenance of the buildings following to be built;
- 4.3.7. Promotes the realization of the *Project* in accordance with the legal requirements and the tasks authorized by this *Agreement*.

V Duration of the agreement:

- 5.1. This *Agreement* shall be considered concluded and take effects from the moment of signature by the parties;
- 5.2. The *Agreement* is concluded in Romanian language, in three copies with equal legal force;
